5. WDVA Equity and Inclusion Officer's Update

Angie Zilliox reported on a self-reporting tool provided by the Bureau of Equity and Inclusion. The committee reviewed and completed the workbook during the meeting.

6. New Business:

Partners in Giving: Chris Kolakowski reported on the Partners in Giving campaign. The agency is coordinating with DOR for Central Office Partners in Giving functions. Several resources were provided to Russ Horton should the committee require them. Because of DVA's organization and operations, virtual and online lines of effort will be considered priority. Voting on Amendments: Russ Horton suggested the committee hold a meeting to amend the CCC bylaws as follows:

Article 2: Membership, Section 2: Number of Members:

"At least one and not more than three voting members will be nominated to the Committee by Division Administrator. The committee will consist of no more than twenty (20) members."

Will be changed to:

"At least one voting member from each WDVA Division shall be nominated by the corresponding Division Administrator. The nomination of voting members from each Bureau is encouraged. The committee shall consist of no more than twenty (20) voting members."

Article 2: Membership, Section 3: Terms of Appointment:

"Committee members will be appointed to three-year terms. New voting members will be appointed to a three-year term by the appointing authority in May of each year, or as needed to replace a vacancy."

Will be changed to:

"Committee members shall be appointed to two-year terms. New voting members shall be appointed to a two-year term by the appointing authority in May of each year, or as needed to replace a vacancy."

Patrick Meyer, seconded by Shannon Miller, moved to pass the amendment from the previous meeting regarding the By-Laws Amendment to Article VI, Section 1: Officer's Titles and Terms.
